DNLA militants lay down arms Myanmar refugees get Covid-19 vaccines in Mizoram

GUWAHATI, NOVEMBER 13

THE MIZORAM government has extended Covid-19 vaccination to refugee Myanmar nationals, currently taking shelter in the state after fleeing the military coup in the neighbouring country, authorities said.

"For two months now, we have been administering Covid-19 vaccines to the Myanmarese living in Mizoram," a senior government official told The Indian Express, adding that they fell under the category of people who could be vaccinated even without an identity proof.

According to official state government records, there are at least 14.254 refugees taking refuge across 11 districts of Mizoram as of November 12. Champhai district, located along the Indo-Myanmar border, is currently sheltering 7,291 refugees, the highest number, followed by Lawngtlai, which has 1,746 refugees.

The official said that it was "practical" to inoculate the refugees, since they were living in Mizoram. "We do not know how long they will be here. Moreover, in the last few months, Mizoram has seen a high number of Covid cases, even though it is coming down now. So vaccinating everyone is a must," he said.

The vaccination process is carried out by chief medical officers in respective districts. "We inform them in advance and they come to vaccination sites arranged by the government," said an official posted in one of the border districts. "We have been testing them upon entry anyway, now we are carrying out vaccinations

NCR cities reel under severe air quality, no relief until next week

GURGAON, NOVEMBER 13

AIR QUALITY continued to be in the 'severe' category in Gurgaon for the second consecutive day on Saturday, recording a reading of 441 on the Central Pollution Control Board's (CPCB) air quality index (AQI) bulletin. This is slightly lower that Friday's AQI

The city's four monitoring stations recorded an AQI over 400 on Saturday - 451 at Gwal Pahari, 431

at Sector 51,438 at Teri Gram and 445 at Vikas Sadan. S Narayanan, member-secretary, Haryana State Pollution Control Board, said the Commission for Air Quality Management's sub-committee held a meeting on Saturday to review the situation and discuss

measures to combat air pollution "For the time being, we will continue to implement GRAP (Graded Response Action Plan) measures under the 'severe' category for at least a week, with a little caution and preparedness for the 'severe plus' category. The air is expected to be relatively calmer over the next two-three days, so the situation depends on

external factors also," he said. Sachin Panwar, a city-based independent air quality scientist, said the air quality is likely to remain 'severe', especially in the mornings, over the next 7-10 days and improve marginally in the afternoon time.

"In the past few days, due to humidity in lower atmosphere and wind direction, the pollutants were not getting any escape route It acted as a funnel to the Indo-Gangetic plain area. With wind speed low (0-2 km/h), most of the particles, coming from northwest, on account of stubble burning and from various local sources of pollution, got stuck in this blanket resulting in this situation," he

The weather bulletin issued by the air quality early warning system for Delhi-NCR on Saturday said the situation is likely to improve marginally but will remain in the 'severe' category till Monday.

The air quality in Noida and Ghaziabad has been averaging between 440 and 470 in the 'severe' category, officials said. Several parts of the city were blanketed by smog. Since AQI in certain pockets of the region has come down from 480, officials claim the trend will continue if stubble burning declines. Crop stubble burning, which ends by the first week of November every year, was extended this time due to a delayed monsoon, further adding to the pollution, officials said.
